Economic Development Corporation:

- a. LCEDC Initiative Update: Close updated the LCEDC Board on the following initiatives:
 Entrepreneur Training Program: Close informed the LCEDC Board that the Entrepreneurial Training Program will be starting on March 22 with the Orientation Day on March 8. Fourteen people attended the first of four Business Education Programs that was held February 15.

 Broadband: Close informed the LCEDC Board that the Broadband committee met. Cirrinity has submitted
 - an application to extend broadband from Hollister to the Pickerel/Pearson area. Close is working with the Wisconsin Department of Transportation, County Highway Department, and Public Service Commission to place conduit under the Highway 52 bridge so that in the future broadband can be extended to the Lily tower at a reduced cost of getting fiber past the Wolf River. Angie Dickenson, director of the Public Service Commission, will be at the Broadband meeting on March 8 to help guide the committee on moving Langlade County's broadband forward.

Education: Close updated the LCEDC Board that Close and Beck presented the City of Antigo Destination Assessment information to students at the Antigo High School during Pride Time. The high school students' answers will be shared at the next Destination Assessment Task Force meeting. LCEDC staff will continue working with the students throughout the semester to creating a marketing plan for the City of Antigo.

- b. UW Extension Business & Entrepreneurship Your Economy Time Series Data Presentation Date Reminder: Close reminded the LCEDC Board that Mark Lange from UW-Extension will be presenting Langlade County economy information at March 19 LCEDC Board meeting.
- c. Discuss LCEDC Upcoming Events and Activities: Beck informed the LCEDC Board about the January/February 2018 Badger Sportsman Magazine article and ad on winter activities in Langlade County. Beck informed the LCEDC Board about the Facebook campaign that ran February 5-9 to promote February events in Langlade County. The post reached over 23,000 people.
