Approve Minutes from 6-30-2017: Motion by Bugni, second by Visser, to approve the Loan Review Board Meeting minutes from June 30, 2017. All Ayes. Motion Carried.

Loan Review Board Member Status and Update: Introductions were given. Close reviewed Loan Review Board members' terms.

Motion by Norrbom, second by Bugni to approve Ben Zelazoski and Dave Vissor to the Langlade County Loan Review Board for a 3-year term ending December 31, 2020. All Ayes. Motion Carried.

Loan Review Board members are invited to listen to the business plan presentations. Entrepreneurial Business Start-Up Grants will be determined based on the business plans presentations. The Entrepreneurial Training Program and Entrepreneurial Business Start-Up Grants are made possible through the Suick Family Foundation. Since 2015, there has been 35 business plans written through the Entrepreneurial Training Program. Former Entrepreneurial Training Program graduates will be on a panel discussion at the LCEDC Annual meeting on May 21.

Close informed the Loan Review Board that the Suick Family Foundation will be sponsoring Roberts Marketing Alliance for a Brain Food for Breakfast session on Social Media Marketing for Small Business on June 14, 2018, from 8 am until noon.
