Minutes of Previous Economic Development Executive Committee Meeting: Motion by Wagner, second by Bauknecht, to approve the minutes from February 11, 2019. All Ayes. Motion Carried.

Langlade County Economic Development Corporation:

A. LCEDC 2019 Budget vs Expense Report: Close updated the LCEDC Executive Committee on the LCEDC 2019 budget vs expense report. KerberRose came on February 27 for the annual financial review. KerberRose will send AR (accounts receivable) adjustment by April and will give a final report at the annual meeting in May. The review did find that LCEDC staff's paid time off was incorrectly calculated because of a rounding error. Adjustments will be made when report is received.

B. Loan Recipients Update: Close updated the LCEDC Executive Committee on loan funds and recipients. Close informed the committee on how certain loans will affect the RLF-Close accounts receivable and bank account

amounts.

- C. RLF Loan Close Out Update: Close reported to the LCEDC Executive Committee that the LCEDC staff attended the CDBG Application training. LCEDC staff learned that new low to moderate income (LMI) levels have come out in February and only the competitive CDBG application is needed if the City of Antigo is awarded the CDBG competitive grant. CDBG competitive application is due May 23, 2019 with grant awards announced in July. The RLF Close out would be submitted once the City of Antigo knows if they received a competitive CDBG grant.
- D. 2019 LCEDC Strategic Plan Update: Close updated the LCEDC Executive Committee that project teams for Labor Pool Retention/Attraction and Job Center/Employer Resources have met in February. These focus effort groups will be meeting again in March. The young professionals groups will also be holding their first meeting in March. The other group is refocusing because of the reconstruction efforts in downtown Antigo.

E. LCEDC Annual Meeting Discussion: The LCEDC Annual Meeting will be on Monday, May 20. Discussion was

held on speakers for the annual meeting and meeting agenda items.

- F. Welcome Center Update: Close updated the LCEDC Executive Committee on February's Antigo Hotel/Motel Commission meeting. The commission discussed the location of a Welcome Center to promote the community as a whole. The Hotel Motel Commission will be meeting twice a month to come up with a plan to create a Welcome Center for Antigo and Langlade County. Information was given on steps going forward and how this would affect LCEDC.
