Approve Minutes from 06/06/2024 and 08/15/2024: Motion by Antoniewicz, second by Norrbom, to approve the Loan Review Board Meeting minutes from June 6, 2024 and August 15, 2024. All Ayes. Motion Carried.

Closed Session: At 8:31 am Motion by Norrbom, second by Antoniewicz, to go into closed session pursuant to Wisconsin Statutes Section 19.85 (1) (E), to review a Langlade County EDC Revolving Loan Fund Requests, review current Revolving Loan Fund status, and update on current loan recipients. Action 1: Motion by Antoniewicz, second by Walrath, to recommend to the LCEDC Board of Directors to approve Antigo Take N Bake, LLC dba Papa Murphy's a LCEDC Revolving Loan not to exceed \$26,400.00 for asset purchase of Antigo's Papa Murphy's contingent upon financial approval from lending institution. The asset loan will be amortized for 7-years with at an interest rate of 6.5%. All ayes. Motion carried.

Loan Review Board Member Terms: Close reviewed the Loan Review Board terms with the Loan Review Board. Zelazoski and Visser's terms expired December 31, 2023, while Smits terms expire December 31, 2024.

Motion by Walrath, second by Norrbom, to approve renewing Ben Zelazoski and Dave Visser Loan Review Board terms for a 3-years ending December 31, 2026 and Gary Smits 3-year term ending December 31, 2027 contingent upon absent members agreeing to the terms. All Ayes. Motion Carried.
